PETITION: Finlay Carson MSP

Finlay,

I am reliably informed that the over 120-signature petition was handed to you this morning - apparently it was greeted with a 'less than warm' reception by a member of your staff, who insisted that the matter had already been given an appropriate response.

Both you and I know that is NOT the case.

In December of last year, you were given notice and provided with information that evidenced D&G Health Board's failure to obtain properly informed (or thereby valid or legal) consent for Covid-19 vaccinations.

Instead of requiring that the health board answer to the evidenced claims directly affecting your constituents and their children, you deliberately and disingenuously obfuscated the true intent into "how they handled the complaint".

The health board's predictably disgusting response was that they "would not engage with Mr Sutherland", muddying the complaint's intent once again. This issue has nothing to do with whether the health board wants to "engage with Mr Sutherland" or not - this is about the health board answering to **their failure to properly inform your constituents - including pregnant women and parents of vaccinated children** - that the genetic product they were injected with was still within phase III clinical trials.

Subsequently, you wrote to the then-health secretary, now-First Minister, always-pointless empty vessel known as Humza Yousaf - who responded "regarding Coronavirus testing".

Not only did you accept this further subversion of the original intent without question, you then fobbed the the whole matter off, stating you would no longer be dealing with it as it was, quote: "against my political beliefs."

That statement was as much a nonsense as it was a lie - which, in a chance meeting outside DGC HQ, you openly admitted when you said to my face that you "shouldn't have said that".
