Notice of Liability

and Subject Access Request

Peter:

On Tuesday, 16th May 2023, an employee of Euroroute Ltd unlawfully removed and detained property belonging to the man known as Tim of the family Dennis [private conveyance VIN/Chassis/Frame No. U5YHC816LAL155493 with CLC plates 'QUETZAL' Kia Ceed CRDI Sportwagon (red)], whilst conducting his natural right to travel under common law jurisdiction. This act was carried out under instruction from officers of Police Scotland, under the false assertion that Tim was traveling within statutory jurisdiction and was therefore beholden to statutory regulations.

We will be pursuing Police Scotland's officers separately on this matter but must also inform you as director of the company Euroroute Ltd that we will be holding you personally responsible in private capacity for direct/art and part/vicarious liability in criminal conduct, including but not limited to: fraud [false claim with non-evidenced and false assertion of obligation to statutory regulations]; and robbery [of private property outside of statutory jurisdiction].

In addition to a Notice of Liability, this correspondence is also a Subject Access Request under Article 15 of the UK General Data Protection Regulations, to which your company is beholden (*explanatory link* https://ico.org.uk/for-organisations/uk-gdpr-guidance-and-resources/individual-rights/right-of-access/how-should-we-supply-information-to-the-requester/). As such, we require from your organisation the following data, which must be supplied within one calendar month of receipt of this notice (https://ico.org.uk/for-the-public/time-limits-for-responding-to-data-protection-rights-requests/):

- 1. All data you hold on Tim of the family Dennis (and/or MR TIMOTHY STUART DENNIS).
- 2. A copy of the order/instruction Euroroute Ltd received from Police Scotland that led to and facilitated the removal of the abovementioned private conveyance.
- 3. Euroroute's contract with Police Scotland along with terms and conditions under which the abovementioned private property was removed.
- 4. The checks & balances + due diligence undertaken by Euroroute employee(s) in order to determine and confirm the lawfulness of the Police Scotland instruction prior to the removal of a private conveyance traveling outside of statutory jurisdiction, along with name and qualifications of the employee who undertook this process.
- 5. Copy of legal title of ownership of the above private conveyance transferred to Euroroute Ltd prior to uplift, in absence of which and in absence of written permission or contract with the title holder, your company has entered into rental agreement with terms & conditions (see below).
- 6. Your company's license for dealing with private conveyances outside of statutory jurisdiction.
- 7. Your company's policy with regards to the incorrect and/or mistaken and/or unlawful removal of private property and subsequent safe return to rightful owner.
- 8. Your company's compensation policy with regards to the above.

In the event that your company fails to provide the lawful justification for the removal of private property outside of jurisdiction (point 4) and/or legal title of ownership of private conveyance (point 5), the following contractual terms and conditions will apply for rental of the abovementioned private conveyance:

- (i) As director of the company involved in the above criminal conduct you will be pursued for remedy in your personal private capacity and under full commercial liability.
- (ii) Absence of due diligence confirming of lawfulness of removal (point 4) and/or legal title of ownership of abovementioned private conveyance (point 5) will incur the following penalties and terms:
 - a) Standing charge for uplift: £1000 (one-off fee)
 - b) Rental charge: £200 per day (or part thereof) from and including date of uplift
 - Rental charge upon receipt of written request for return of private property to owner [Tim of the family Dennis]: £500 per day (or part thereof), commencing at 00:01 on the day after Royal Mail confirmation of delivery
- (iii) In event of failure to pay true bill for charges incurred and/or return of private property belonging to Tim of the family Dennis, remedy and compensation will be pursued against Peter Henryson Stewart in personal private capacity under full commercial liability via lawful affidavit + commercial lien process.

We have enclosed for your information and perusal Common Law Court documents: (i) deed of lawful ownership; (ii) Road Worthy Certificate, and (iii) Surety Bond (insurance) for the abovementioned private conveyance. We also inform you that the conveyance in question has been exported from statutory jurisdiction [vehicle] to common law jurisdiction [private property/conveyance]. We also enclose our notice to Lyndsey Nicolson (Police Scotland Inspector, Castle Douglas), who to date has not responded and currently stands in default of that notice.

Please be aware that any response to this notice may be used as evidence in future proceedings and must therefore be provided under penalty of perjury and under full commercial liability.

Legal Maxim, Black's Law Dictionary (11th Edition):

Furtum est contrectatio rei alienae fraudulenta, cum animo furandi, invito illo domino cujus res ills fuerat.

Theft is the fraudulent handling of another's property, with an intention of stealing, against the will of the proprietor, whose property it had been.
