## NOTICE of DEFAULT

Lyndsey,

On 1st June 2023 you were issued a Notice of Conditional Acceptance upon Proof of Claim, confirmed by Royal Mail as delivered to Castle Douglas police station on Friday 2nd June 2023 under tracking reference number KL239931467GB (<https://www.royalmail.com/track-your-item#/tracking-results/KL239931467GB>).

On 13th June 2023 you were issued a Notice of Default and Opportunity to Cure, confirmed by Royal Mail as delivered to Castle Douglas police station on Wednesday 14th June 2023 under tracking reference number NY841162747GB ([www.royalmail.com/track-your-item#/tracking-results/NY841162747GB](http://www.royalmail.com/track-your-item#/tracking-results/NY841162747GB)).

Despite requiring a response within seven [7] days and ten [10] days respectively, to date there has been no correspondence from you or anyone else under the employ of Police Scotland in connection with the lawful notice.

Initially, we assumed there was perhaps some confusion about the requirements stipulated within the notice, or that more time was required in order to respond in full with the information and evidence required; however, given that two such notices have now been issued with no response, we can only presume that neither you nor anyone in the employ of Police Scotland is in possession of the documented lawful obligation, presentable as material evidence, to validate any claim that We the People are thereby bound by statutory legislation such as the Road Traffic Act 1988.

**In any case: you are hereby informed that you are now in DEFAULT of this Lawful Notice process.**

However, as we remain at all times reasonable, fair and honourable in our affairs, we provide this FINAL opportunity and hereby grant a further ten [10] days for the provision of the required information and evidence as set out in our first notice, a copy of which is enclosed for your convenience.

**Failure to respond in an adequate fashion in good faith with the evidence required will result in a Notice of Estoppel by Acquiescence, and will thereby constitute agreement, tacit or otherwise, that:**

- 1. Police Scotland abandons all claims against Tim of the family Dennis, and thereby the private property belonging to him, via process of estoppel;**
- 2. The private conveyance [VIN/Chassis/Frame No. U5YHC816LAL155493 with CLC plates 'QUETZAL' Kia Ceed CRDI Sportwagon (red)] belonging to Tim of the family Dennis was removed unlawfully; and that, therefore**
- 3. It would be lawful for the property belonging to Tim of the family Dennis [private conveyance VIN/Chassis/Frame No. U5YHC816LAL155493 with CLC plates**

**'QUETZAL' Kia Ceed CRDI Sportwagon (red)] to be willingly returned or peacefully retrieved from whatever location at which the conveyance is being unlawfully withheld.**

**Failure to provide adequate evidence as stipulated will constitute lawful justification for the immediate return or peaceful retrieval of the property [private conveyance VIN/Chassis/Frame No. U5YHC816LAL155493 with CLC plates 'QUETZAL' Kia Ceed CRDI Sportwagon (red)] belonging to Tim of the family Dennis.**
